While on the Commission, Carlito served on the board, and on several committees, of the National Association of Regulatory Utility Commissioners; as President of the Western Conference of Public Service Commissioners; on the board of the National Regulatory Research Institute; on the FCC's Intergovernmental Advisory Committee; and on the Federal-State Joint Conference on Advanced Telecommunications Services.

Before joining the Commission, Carlito practiced law in Hawaii at Cades Schutte LLP, primarily handling business, finance, real estate, and other transactional matters. He is licensed to practice law in the State of Hawaii and the U.S. District Court for the District of Hawaii, and is a member of the Hawaii State Bar Association and the American Bar Association.
